

**GOOD SAM BLUE CRAB FUN BUNCH MEETING**

**FINANCIAL ACTIVITIES:**

He would like everyone to send him newsworthy stuff, e.g., new grandchild, new rig, went to a great campground (or a lousy one), enjoying ourselves in Florida, etc. Just a few lines to keep everyone informed. If Tom doesn't get info from the club members, we won't get a newsletter.

**Scout out campgrounds close to home.** – We agreed to do this. If you happen to drive by a campground that you haven't visited in recent years, stop by to look it over. Things change and maybe we can find nice campgrounds closer to home. (Shorter distances really help those still working to attend campouts.) If you visit one, bring your findings to the club meeting to share with others.

Instead, she will put a block of sites on **hold** for each campout (The campgrounds will only hold campsites for a limited amount of time) We will each be responsible for making and paying for our own reservations for those campsites before the deadline date. Note: You will also be responsible for canceling the reservation, as necessary.

### **NEW BUSINESS**
